I've checked with the UC Davis College of Veterinary Medicine and we are able to provide a response to item 1 of your request. Item 2 is not information that we maintain. Our consulting firm has been collaborating with the FDA and other researchers on the canine diet-associated Dilated Cardiomyopathy topic. UC Davis College of Veterinary Medicine has also collaborated with the FDA. We are requesting the following information from UC Davis veterinary teaching hospital:

1. The veterinary cardiology service's annual overall new case numbers for each year between 2002 through 2019.
